Galveston College Foundation (the Foundation) submits that throughout its existence to date and in the future, it qualifies as a public charity under Internal Revenue Code 509(a)(1) by satisfying the requirements of Regulation 1.1709A-9(f)(3) as follows:

(i) Ten Percent Test: The Foundation has historically and normally can be expected in the future to receive over 10% of its total support from the general public.

(ii) Attraction of Public Support: The Foundation provides access to higher education for students in the greater Galveston area. Because of its commitment to the education of local students that will stay in the area, it has attracted gifts from individuals, corporations, and foundations with ties to the community. Through the Foundation's annual appeals, a broad constituency of approximately 3,902 donors is reached. The Foundation is re-designing and re-evaluating its fundraising campaigns to engage and attract new donors. Additionally, the ongoing impact of the pandemic has affected contributions, and the Foundation is working to source new donors. New campaigns have been launched to support students through Emergency Student Scholarships, appeals based on most significant needs, and targeted appeals to Galveston College alumni.

(iii) Sources of Support: The Foundation historically has received support from a broad representative number of foundations and individuals, rather than receiving almost all of its support from the members of a single-family or small group of individuals. During the fiscal year 2022,

(iv) Representative Governing Body: The Foundation's governing body comprises 16 area civic and business leaders. The majority of the board members are not significant donors or disqualified persons.

(v) Availability of Facilities or Services and Public Participation: The Foundation's programs impact the students of the Galveston community and surrounding areas. In 2022, approximately 238 students received financial assistance from the Foundation.

CONCLUSION: The Foundation believes it qualifies as a publicly supported charity described in IRC 509(a)(1) pursuant to the facts and circumstances test found in Treasury Regulation 1.170A-9(f)(3). The Foundation has and will continue to receive more than ten percent (10%) of its total support from qualifying public sources. It serves all Galveston area high school students. The Foundation is governed by a public board and possesses all the characteristics that describe organizations that meet this test.
